Alison Aiton introduced a short presentation from the Information Commissioner's Office outlining the new GDPR regulations that will come into force in May 2018. This will have ramifications for the Commission in dealing with patient sensitive information.

5. CEO Update

Visit reports

The Homelessness themed visit report was published in July with good coverage and has been well received.

Local visits

Reports are being published and attracting increased media coverage.

Forensic themed visit

The report will be published on 30 August 2017

Investigations/casework

The Mr QR investigation will be published in mid-September. The Commission is planning facilitated sessions to review its investigations process which will input from other organisations that carry out investigations.

The Commission is involved in a potentially important case about the boundaries of using the Mental Health Act in treatment for physical conditions.

Influencing and policy work

The recruitment of the Chair for the review of use of the Mental Health Act for people with learning disability and autism is still awaited but the Scottish Government expect to announce it by October.

Adults with Incapacity Act reform

Further meetings have been held with Scottish Government which expects to issue formal consultation by end of the year.

Investigation of deaths

The Scottish Government is consulting on the proposals we sent them in November 2015 to improve homicide investigations; a separate review on deaths of detained patients is getting underway chaired by Prof Craig White. Colin McKay and Gary Morrison will be involved. The Commission is concerned about Healthcare Improvement Scotland changing the suicide review process to a potentially less rigorous system and are seeking clarification from HIS

Conferences

Colin McKay and Gary Morrison spoke to the Royal College of Psychiatrists international conference on capacity/law reform. Colin McKay presented at 3 sessions at IALMH conference in Prague, funded by IALMH.

Sharing intelligence

The Commission are part of this network co-ordinated by Healthcare Improvement Scotland, which published a report of its work in August.

Staffing

New medical practitioner Ritchie Scott is now in post. Alison Thomson has been appointed deputy chair of the Royal College Psychiatrists Combined Committee for Accreditation.

Alison Thomson reported that she was continuing to work on improving the report and presenting more meaningful information. In the future it was hoped to link groups of recommendations to the Care Pathway Care Planning. The report will be published on the website.

The Board invited staff to consider how to make the introductory sections more hard hitting. Norman Dunning highlighted that corporate parenting duties need to be included in the report next year. The Board noted that the Commission has exceeded many of the key performance indicators and this should be acknowledged.
